



Subject:- Fixation of Disposal Targets for the F.Y. 2016-17 – reg.

Sir,

I am directed to refer to your office letter F. No. 398/01/2016-BT/1894 dated 25.05.2016 on the above mentioned subject and to say that the Board has fixed a target of Rs. 1153.19 Cr. for disposal of seized/ confiscated goods for the year 2016-17. The Zone wise targets are given in Annexure – A.

2. You are requested to convey the targets to all the field formations and closely monitor their performances for achieving the same. Periodical progress reports may be obtained from field formations, as prescribed, and a compiled report may be sent to the Board for monitoring the achievement made by respective zones.

3. The Audit Report DAP No. A118 for the year 2012-13 (Customs) from Comptroller and Auditor General of India relating to Disposal of seized/ confiscated goods pointed out among other things that the certain Zones are not allocating targets to the respective Commissionerates in their jurisdiction. Therefore, while conveying the disposal targets to the Zones, it may be mentioned that appropriate allocation may be made Commissionerate wise.

4. Also when the statement furnished by DoL vide 398/01/2016-BT/1894 dated 25.05.2016 was examined, it was noticed that in respect of Mumbai-III Customs Zone, the figures did not reflect the actual value of stock as on 31.03.2016. The same was rectified after getting a revised report from Mumbai-III Customs Zone (copy enclosed). The records at DoL may kindly be modified accordingly.
